



**On April 2, 2024,** On April 2, 2024, The City of Crestwood will ask residents to vote on Proposition A, a \$33 million bond issuance for several parks and recreation projects. If approved, it would allow the city to make the most significant park improvements in decades and cater to the current and future needs of the community.

## A PLACE FOR Community.

Resident surveys, town halls, and other public outreach events identified parks and recreation needs within the community. Proposition A includes plans for several projects, including:

- Constructing a new community center at Whitecliff Park
- Transforming the existing community center into a pickleball and family games complex
- Replacing the Crestwood Park playground
- Adding a nature play area to Whitecliff Park
- Adding a walking trail loop to Whitecliff Park
- Adding a pedestrian bridge to connect Whitecliff Park to the Lodgepole neighborhood

## A PLACE FOR Recreation.

The largest project proposed in Proposition A is constructing a new community center at Whitecliff Park. The new facility features something for all ages, including updated equipment and new amenities such as an indoor walking and jogging track, additional meeting spaces, a multi-use gymnasium, and an expanded fitness center.



## A PLACE FOR Families.


The existing community center will be transformed into a family games complex, featuring areas for indoor/outdoor pickleball games, gathering places for residents to play cornhole, shuffleboard, bocce ball, etc., and food and beverage service.

## PROJECT FUNDING

In the General Municipal Election on April 2, 2024, Proposition A will ask voters for the authority to issue \$33 million in bonds for this project. Approval requires 57.14% of votes in favor.

## PROJECT TIMELINE

If approved, construction on the new community center will start in 2025, with completion scheduled for 2026. Updates to the current facility and other parks and facilities would follow.
