## What is Prop A?

On April 2, 2024, Crestwood voters will consider Proposition A, a \$33 million bond issuance for several parks and recreation projects.

If approved, it would allow the city to make several park improvements, including:

- Building a new community center
- Renovating the existing community center
- Replacing the Crestwood Park playground
- Adding a nature playscape area and walking trail loop to Whitecliff Park
- Building a pedestrian bridge to connect Whitecliff Park to the Lodgepole neighborhood

## A PLACE FOR Community.

Proposition A's largest project is a new community center at Whitecliff Park, proposed after a comprehensive Parks Master Planning process in 2022. This plan, driven by town halls, a resident survey, and outreach, revealed a strong desire for:

- Indoor walking/jogging track
- More fitness and wellness programs
- Improved weights and cardio fitness area
- Expanded indoor sports court
- Larger and more functional community event and meeting spaces

## A PLACE FOR Recreation.

The existing community center will be transformed into a family games complex, featuring areas for indoor/outdoor pickleball games, gathering places for residents to play cornhole, shuffleboard, bocce ball, etc., and food and beverage service.

## Project Funding & Timeline

In the General Municipal Election on April 2, 2024, Proposition A will ask voters for the authority to issue \$33 million in bonds for this project. **Approval requires 57.14% of votes in favor.** Prop A will cost most Crestwood homeowners \$20.58 per month. The chart to the right illustrates the impact Prop A would have on property tax bills.

HOME VALUE	MONTHLY PROPERTY TAX
\$150,000	\$12.35
\$200,000	\$16.47
\$250,000	\$20.58
\$300,000	\$24.70
\$350,000	\$28.82

If approved, construction is slated to begin in 2025, with the new community center opening in 2026. Updates to the current facility and other parks will follow.
